Based on Articles 14 and 15 of the UEFA Women's Champions League Regulations (UWCL Regulations) the following draw procedure has been adopted by the UEFA Women's Football Committee

MATCH SYSTEM (PARAGRAPH 15.01 OF THE UWCL REGULATIONS)

15.01 The first and second qualifying rounds are played in the form of mini-tournaments with semi-finals, a final and a third-place match, all single-leg ties, hosted by one of the participating clubs. If, due to rebalancing for the UEFA Women's Champions League titleholder and/or due to the number of entries in the competition, the number of clubs in the first qualifying round of the champions path and/or the second qualifying round of the league path are not divisible by four, mini-tournaments may be played with three teams, with a single semi-final and one team qualifying automatically for the final. In all cases, if the score is equal at the end of normal time, two 15-minute periods of extra time are played. If one of the teams scores more goals than the other during extra time, that team is declared the winner. If the score is still equal after extra time, the winner is determined by a penalty shoot-out (see [Paragraph 21.03](#)). The winners of the finals qualify for the next round of their respective paths.



DRAW SYSTEM (PARAGRAPHS 14.01, 14.02 AND 14.04 OF THE UWCL REGULATIONS)

- 14.01 Clubs are seeded for these draws in accordance with the club coefficient rankings established at the beginning of the season (see [Annex D](#)) and with the principles set by the Women's Football Committee. If, for any reason, any of the participants in the rounds in question are not known at the time of the draw, the coefficient of the club with the higher coefficient of the clubs involved in undecided ties is used for the purposes of the draw.
- 14.02 For the draws for the first and second qualifying rounds, which are played in the form of mini-tournaments, the clubs are divided into two pots. For four-team mini-tournaments, the clubs are all drawn into semi-final pairings with the clubs from pot 1 designated as the home teams. For the final and third-place match, the club with the highest coefficient in the tie concerned is designated as the home team. If it is necessary to draw clubs into groups of three teams, the club with the highest coefficient qualifies automatically for the final and is designated as the home team for that tie; the remaining two clubs play a single-leg semi-final, with the club from pot 1 designated as the home team.
- 14.04 The UEFA administration may form groups for the qualifying phase draws in accordance with the principles set by the Women's Football Committee. Clubs from the same association cannot be drawn against each other.

DRAW CONDITIONS

PROHIBITED TEAM CLASHES

Based on the UEFA Executive Committee decisions valid at the time of the draw, clubs from the following associations cannot be drawn into the same group:

Champions path

- Armenia / Azerbaijan
- Kosovo / Bosnia and Herzegovina
- Kosovo / Serbia
- Ukraine / Belarus

League path

- Ukraine / Belarus

COUNTRY CLASHES (APPLICABLE FOR LEAGUE PATH ONLY)

Clubs from the same association cannot be drawn into the same group.



CHAMPIONS PATH

POTS

- The 28 clubs (22 directly and 6 winners of the first qualifying round mini-tournaments, indicated for the purposes of this draw as Winner CH-P Q1 Gr1 to Gr6) are divided into 2 pots of 14 clubs and will be drawn into seven four-team mini-tournaments.
- Within each four-team group, clubs are drawn into two semi-final ties, with the clubs from pot 1 designated as the home teams of semi-finals 1 and 2 respectively.
- As the clubs qualifying from the first qualifying round are not known at the time of the draw, the coefficient of the club with the highest coefficient of the four teams involved in the undecided mini-tournament ties is used for the seeding for the purposes of the draw. Therefore, if a club in a first qualifying round mini-tournament has a coefficient that would entitle it to be seeded for the second qualifying round draw, that group is automatically seeded for the draw.

DRAW PROCEDURE

- The 14 seeded clubs in Pot 1 will be drawn into the home team positions of the ties in the groups in numerical order, starting with group 1 and completing the draw with group 7, as follows:
 - The first ball drawn is allocated to semi-final 1 in group 1
 - The second ball drawn is allocated to semi-final 2 in group 1
 - The third ball drawn is allocated to semi-final 1 in group 2
 - The fourth ball drawn is allocated to semi-final 2 in group 2
 - The same process applies for all seven groups.
- The 14 unseeded clubs in Pot 2 will be drawn into the away team positions of the ties in the groups in numerical order, starting with group 1 and completing the draw with group 7, as follows:
 - The first ball drawn is allocated to semi-final 1 in group 1
 - The second ball drawn is allocated to semi-final 2 in group 1
 - The third ball drawn is allocated to semi-final 1 in group 2
 - The fourth ball drawn is allocated to semi-final 2 in group 2
 - The same process applies until all seven groups are complete.
- If a draw condition applies, the club drawn is placed in the same position of the first available group in numerical order and another club will be drawn from the same bowl into the free position of the current tie. Similarly, when completing the ties in the next group, the club will be drawn from the relevant bowl in order to respect the seeding principles. Should a clash be possible when drawing the last groups, the clubs will be drawn and will be assigned to the groups.



LEAGUE PATH

POTS

- The 15 clubs are divided into 1 pot of 8 clubs and 1 pot of 7 clubs and will be drawn into three four-team mini-tournaments and one three-team mini-tournament.
- Within each four-team group, clubs are drawn into two semi-final ties, with the clubs from pot 1 designated as the home teams of semi-finals 1 and 2 respectively.
- For the group with three teams, the club with the highest coefficient is seeded directly to the final and designated as the home team of that tie; the remaining two clubs play a single-leg semi-final with the club from pot 1 designated as the home team.

DRAW PROCEDURE

- The 8 seeded clubs in Pot 1 will be drawn into the home team positions of the ties in the groups in numerical order, starting with group 1 and completing the draw with group 4, as follows:
 - The first ball drawn is allocated to semi-final 1 in group 1
 - The second ball drawn is allocated to semi-final 2 in group 1
 - The third ball drawn is allocated to semi-final 1 in group 2
 - The fourth ball drawn is allocated to semi-final 2 in group 2
 - The same process applies for all three four-team groups
 - Continuing the draw with the three-team group, a ball is drawn and held in suspense until a second ball is drawn and the coefficients of the two clubs known, determining their positions in group 4:
 - The club with the higher coefficient is allocated as home team of the final
 - The other club is allocated as home team of the semi-final.
- The 7 unseeded clubs in Pot 2 will be drawn into away team positions of the ties in the groups in numerical order, starting with group 1 and completing the draw with group 4, as follows:
 - The first ball drawn is allocated to semi-final 1 in group 1
 - The second ball drawn is allocated to semi-final 2 in group 1
 - The third ball drawn is allocated to semi-final 1 in group 2
 - The fourth ball drawn is allocated to semi-final 2 in group 2
 - The same process applies until all three four-team groups are complete
 - Finishing the draw with the three-team group, the last ball draw is allocated to the semi-final tie of group 4.
- If a draw condition applies (prohibited team clash or country clash), the club drawn is placed in the same position of the first available group in numerical order and another club will be drawn from the same bowl into the free position of the current tie. Similarly, when completing the ties in the next group, the club will be drawn from the relevant bowl in order to respect the seeding principles. Should a clash be possible when drawing the last groups, the clubs will be drawn and will be assigned to the groups.
